

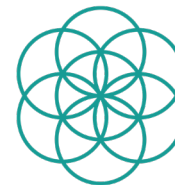

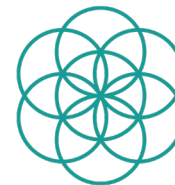


STANDARD DEVELOPMENT & WORKING GROUPS

A key component of RSB membership is members' participation in the ongoing development of the RSB Standard — examining cutting edge issues and bringing their expertise and perspectives to the multi-stakeholder development process. Members are able to help shape and drive the development of the RSB Standard and ensure that it remains a highly credible and practical tool for the development of your work in the bio-based and circular economy.

In 2021 the main Standards work will include a review of our Principles & Criteria, which is the core of the RSB Standard, as well as other amendments and regulatory updates. The formal Standards Workplan will be approved by the RSB Board of Directors in early 2021, but the following represent the main priorities for 2021 from the RSB Secretariat's perspective.

Standard Development Topic	Start Date
RSB Standard Amendment for Woody Biomass: the Amendment has been developed with support of the Standards Working Group and consultation with members is ongoing with adoption by the Assembly of Delegates expected for early 2021.	Q1
RSB Principles & Criteria Review: under ISEAL Codes of Conduct credible standard organisations should review their principles and criteria every five years. RSB will kick-off its review in early 2021 with the aim of completing by early 2022. This is an opportunity for RSB to streamline and improve its standards and members are invited to engage fully in the process.	April
RSB Certification for Low Carbon Transport Services: This addendum to the RSB Advanced Products Standard has been drafted by the RSB Secretariat and is currently reviewed by experts.	Q2
RSB CORSIA: RSB submitted its standard to ICAO in 2020 for approval and a decision is expected in November 2020. However, there may be additional requirements from ICAO that RSB will need to implement. Members will be updated on developments.	TBC
RSB EU RED II: RSB submitted its standard for recognition by the European Commission in 2020 – the first certification organisation to do so. A decision is expected in July 2021. Additional requirements are expected in early 2021 as the Commission publishes 'Implementing Acts' on specific issues. RSB will be ensuring that the RSB RED II Standard aligns with these requirements. Members will be updated on developments.	TBC
